WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., permits a contracting unit to authorize the procurement of a for-profit entity to provide "concession" services, which includes the right to sell goods or services on public property or by use of public property; and

WHEREAS, the Commissioners of the MPWC determined that it would be appropriate and in the best interests of its customers to authorize a concession for water line protection services for it franchise customers; and after DCA approval of and full compliance with Competitive Contracting under N.J.S.A. 40A:11-4.1(j) and a full and fair award of such by Resolution 2015-13; and

WHEREAS, a concession can save a customer/constituent of the Commission almost a minimum of \$60 per year if they seek the coverage and as much as \$2-6,000 on average for a claim; and no cost to the Commission for the concession except the use of its logo; and

WHEREAS, procurement of a for-profit entity to provide these services needed is consistent with the provisions of competitive contracting used to secure them and the original contract(s) for these services was awarded based upon the most advantageous price and other factors: and

WHEREAS, N.J.A.C.5:34-9.4(d) requires that the governing body pass a resolution authorizing the procurement of a concession, including the method to be used to procure and award the concession, which method had been determined to be the use of competitive contracting and this time is determined to be a Non-Fair and Open award of a 2 year renewal of that same agreement at the prices; and

WHEREAS, the Local Public Contracts Act requires that the governing body pass a resolution uthorizing the choice of the Non-Fair and Open Award Process; and requires that that the award be made by the Governing Body after notification by the QPA of receipt of all requisite documents; and

WHEREAS, The Commission entertained these as agenda matters and after allowing for public comment prior to a vote and upon a roll call vote in open session took the following action:

THEREFORE BE IT RESOLVED by the Commissioners of the MPWC that the Award of the Concession as a renewal of the Agreement as a 2 year Non- Fair and Open Award is hereby made and the C.O.O. is hereby authorized to execute the agreement with HomeServe to procure a renew the concession for the use of the MPWC logo, consistent with this Resolution and N.J.A.C. 5:34-9.4.

ALSO BE IT FURTHER RESOLVED by the MPWC that the above Resolution and Award was made by a Unanimous vote of the Commissioners assembled in publicly advertised meeting of that date. RESOLUTION AUTHORIZING THE AWARD AND EXECUTION OF A WATER MAIN ASSET MANAGEMENT AGREEMENT PURSUANT TO THE WATER SUPPLY PUBLIC-PRIVATE CONTRACTING ACT. N.J.S.A. 58:26-19 et seq. SUBJECT TO THE REQUIRED APPROVAL OF THE STATE AGENCIES

WHEREAS, the MERCHANTVILLE-PENNSAUKEN WATER COMMISSION (hereafter "MPWC" or "Commission") is a governmental regional water authority created in 1926 by Supreme Court and permanently by the subsequent agreement and respective ordinances of each of the municipalities named therein in accordance with NJSA 40:62-108; and

WHEREAS, the MPWC maintains a potable water system which supplies thousands of customers, businesses, and industries with an extensive distribution system of over 220 miles of underground water mains; and the passage of the Water Quality Accountability Act required the replacement of an increased percentage of the water mains each year by every water utility and in excess of the amount the MPWC might necessarily otherwise replace in a year; and

WHEREAS, the MPWC on September 12, 2019 approved a Resolution for a RFQ/RFP competitive procurement process pursuant to N.J.S.A 58:26-19 et seq., (New Jersey Water Supply Public-Private Contracting Act referred herein as the "Act"), to obtain proposals from qualified firms to provide engineering, technical, consultative, rehabilitation, re-lining, excavation, construction, and rehabilitation maintenance services for its water main distribution system and for assistance to its Director of Engineering as to such; and thereafter secured approval of the Office of the State Comptroller for its proposed procurement documents; and first began advertising on October 14, 2019; and

WHEREAS, after public advertising commencing first on October 14, 2019 and again on October 16, 2019, as well as continuous advertising via internet and website, the MPWC established a deadline to receive Proposals of Wed., November 26 at 10:30am and the MPWC received a joint proposal from the companies Suez Advanced Water Solutions/USCI, Inc (hereafter jointly Suez) which was timely and responsive; and

WHEREAS, the MPWC evaluation committee following a review of the proposal, and the application of the pre-proposal evaluation criteria, selected SUEZ as qualified and as the sole qualified applicant selected them for the negotiation of a main services agreement; and

WHEREAS, the Evaluation Team and the MPWC Director of Engineering, in-house General Counsel, and Chief Operating Officer and various SUEZ personnel and attorneys had additional meetings, negotiations, and interviews with the respondents. Initially negotiations caused a delay in the February 2019 noticed hearing date. Meanwhile, as the parties continued negotiations, and then the Commission reconsidered its finances in light of its needs and obligations to build treatment plants necessitated by the new Drinking Water Standards having been revised and/or adding previously unregulated contaminants and questions regarding financing of the plants and state support through various funds. Delays were further occasioned by the parties need for discussions and clarifications required of the DEP regarding their

interpretation and enforcement of the WQAA provisions regarding re-lining and/or replacement of water mains, and finally, but not least, the impact of the Covid-19 Pandemic slowed and complicated all processes; and

WHEREAS the MPWC successfully completed negotiations on the agreement (the "Main Asset Services Agreement") and advertised timely for the Public Hearing when on November 10, 2020, it RE-Noticed a 60 Notice of the Public Hearing by service on all the required state Agencies and by published advertisement in newspapers noticing the proposed contract and the public hearing for January 11, 2021. The legal advertisement and website posting described the contract terms and that the contract was available at the Commission and on its website; and

WHEREAS thereafter the MPWC advertised a 14 day Notice as required by the statute beginning on December 28 and again on December 30 for the Public Hearing on the agreement for January 11, 2021, ; and in the meantime, having been advertised and made available by website and for public inspection the draft agreements since December 8, 2020 and made available contacts for questions or for in person public inspections; and at no time did any member of the public appear or comment; and no one sought documents or inspections and

WHEREAS, pursuant to the Act, the MPWC made this Agreement available for inspection via website since December 8, 2020 and physically made hard copies executed by USCI available the four days preceding the conduct of the public hearing and no member of the public commented or appeared at any Hearing; though MPWC Counsel and Court Reporter were available in person to allow inspection and testimony at the MPWC Hearing site, and further no witnesses attended virtually or live nor did any make submission, and none was received during the post-hearing comment period during which the hearing record was held open; and

WHEREAS, in accordance with the Act and having considered all evidence and presentations and conduct regarding the contract of which it has been made aware, the MPWC knowing its approval to be subject to the Approval of the State Agencies resolves as follows:

NOW BE IT THEREFORE BE IT RESOLVED on this the 11th day of February 2021 by the COMMISSION THAT:

- 1. The Water Main Asset Management Services Agreement is approved with the terms as executed and as presented to the Commission subject to the required processes of the Act and the approvals of the State agencies and any further submission to this Commission as maybe required; and

The Chief Operating Officer of the Commission, Michael Saraceni is hereby authorized and directed, when appropriate, upon receipt of such approvals or expiration of the Statutory time period, to execute the Water Main Asset Management Services Agreement with SUEZ Advanced Water Solutions/USCI, Inc., so as to provide Water Main Asset Management Services to the MPWC in accordance with the Act; and

WHEREAS, the Treasurer, the Chief Operating Officer and the Designated Qualified Purchasing Agent recommended that procurement cards be utilized where appropriate for purchases of the Water Commission; and by Resolution # 2017-07 on June 8, 2017 the Commission approved a Procurement Card Plan; and

WHEREAS, FIA Card Services, N.A., a Bank of America Company, had been awarded the State of New Jersey contract to provide agencies the ability to purchase goods and services using a P-CardIndex#T-1654, Contract #84675, and

WHEREAS the following internal controls are set for compliance with the statutory authorization and the Local Finance Notice 2013-17 rules will be in place, and

- e. When applicable and bids are advertised, the bid documents include that the payments may be made by procurement card so the local unit receives in their bid prices any discount fortimely payments.

All purchases with the P-card shall be approved by both the C.O.O. and the program manager in advance and reported monthly and separately to the Commission;

Purchases are limited to \$3,400.00 per purchase/aggregate of \$6,000.00 per month per user.

Users to expeditiously provide all receipts to the program manager, who will compare receipts to the computer-generated usage report provided by the card company. Returned material must be reported to the Program Manager quickly to ensure either the charge is cancelled, or the local unit receives proper credit.

The C.O.O. and program manager are authorized to create P-Card procedures to assure compliance with these requirements; and

WHEREAS the Eagle sub-contractor engaged for the masonry work who did this has been defunct and out of business for years; and Eagle has proposed a compromise solution which would involve them contributing approximately half of the time and cost of correction in this matter; and

WHEREAS the MPWC has consulted Special Construction Counsel as well as their Director of Engineering both of whom for reasons of law, engineering, construction and practicality have all recommended this settlement as in th MPWC's best interest; and

WHEREAS there existed a need for the MPWC to procure the certain licensed professional services from professionals deemed qualified from announced and publicly advertised criteria and the service of the professional services is authorized to be engaged without bidding as a professional service under the Local Public Contract Law because such services are to be respectively performed by a person or persons authorized by law to practice a recognized profession which is regulated by law and it is not prudent or possible to simply obtain bids; and

WHEREAS the Local Public Contracts Law, NJSA 40A:11-1, et. seq. authorizes qualification of such professionals and pursuant to the State's Local Unit Pay-to-Play, N.J.S.A. 19:44A-20.4 et seq., and establishes a "fair and open" process compliant with the rules and restrictions set forth therein which requires a resolution authorizing the qualification and/or award of contracts for professional services after established criteria and publicly advertised, and the Commission having done so; and

WHEREAS the need for such services were publicly advertised with criteria and qualifications made public in advance and an Open and public return date with all applications opened publicly; and only two Counsel responded and the One being Brett Wiltsey, Managing Partner on behalf of his Firm, and his being one of the two Qualified firms in the pool pursuant to MPWC Resolution 2021-29; and

WHEREAS he has worked with our Director of Engineering and our contracted Engineers on the National Highway Treat Plant Upgrades and their financing and having left that firm for a larger more nationally recognized firm of Obermayer Rebmann Maxwell & Hippel LLP who has made him their managing partner here in New Jersey and he has now sought acknowledgement of the qualifications of this firm as being equivalent or superior to those in the Pool; and

NOW, THEREFORE, the Commission finds that it has proceeded in accordance with the procedures required under New Jersey law for appointment under the Fair and Open Process which it hereby deems this to have been and when originally advertised; and

FURTHER BE IT RESOLVED in duly advertised Public Meeting as follows: that the President, and Secretary are hereby authorized and directed to execute the necessary documents to designate the following professionals for the Commission year regarding qualifications for Bond Counsel hereby finds the following Bond Counsel to have met the Qualifications to be Bond Counsel at the discretion of the Commissioners and amend Resolution 2021-29 and subject to reaching acceptable terms and conditions in contract language for retention as professionals and or per project:

• Parker McCay, Mt. Laurel, NJ • Obermayer, Rebmann Maxwell & Hippel LLP, Mt. Laurel NJ The MPWC hereby finds that the process used in changing firms may require the Commission to utilize the Non-Fair and Open Award of a professional contract with all the requirements thereof.
